Our clear aim is to become a recognised ‘Employer of Choice’ within our sector with a workforce that fully reflects the communities we serve. Anderselite employs a large number of staffs from the local community. To help us achieve this, we have three key aims:

Communities

Charity

Additionally, all employees are allocated an additional day of annual leave each year to participate in a charity event of their choice to support a chosen Groups charity or a charity local to an individual branch.

Charity activities are managed by the charity committee, a group of employees from across the Group. Official annual charities are nominated by our employees; this ensures there is a strong personal connection to the charities selected.

Commitment to Early Careers

Environmental Sustainability
